THIS AGREEMENT BETWEEN THE KIWANIS CLUB OF ENGLEWOOD-CAPE HAZE AND THE EXHIBITOR IS SUBJECT TO THE FOLLOWING CONDITIONS.

1. Electric service is provided at an additional cost. You must provide your own extension cords.
2. No construction may exceed the height of eight (8) feet. This includes signs hanging from the ceiling or on the wall. Signs must be printed on one side only. Materials for decorations, etc. shall be flameproof. Gym floors may not be harmed. Nothing shall be painted, nailed or glued to the floor or walls. You are responsible for any damage to the floor.
3. Exhibitors shall not assign or sublet any part of their space herein contracted, without the written consent of the Kiwanis Club manager.
4. Insurance desired by the exhibitor must be placed at his own expense. The Kiwanis Club of Englewood-Cape Haze will not be held responsible for any type of loss, claims, demands or actions of any nature by any party in connection with the operation of their space in the show.
5. Exhibitors may distribute literature, etc. from their booth and take orders for merchandise within the boundaries of their booth. Unnecessary noises, loud attraction getters or loud radio, television, organ music, or other types of demonstrations are forbidden.
6. Exhibitors shall be notified in advance by mail of show's move-in schedule and show hours. Show hours are 9:00 a.m. - 4:00 p.m. on Saturday, January 16, 2010. Set up hours are 4:00 p.m. until 8:00 p.m. Friday, January 15.
7. All booths must be attended during show hours. Any exhibitor failing to occupy space contracted for is not relieved of the obligation of paying for such space. If not occupied by show opening time, such space will be possessed by the Show manager. The Show manager reserves the right to re-sell such space.
8. In the event of an emergency, if it becomes necessary to postpone or cancel the show, all money paid by the exhibitor for space will be refunded and the exhibitor waives any claim for damages.
9. The Show manager reserves the right to alter locations of exhibitors or booths as shown on the official floor plan, in the best interest of the show.
10. The Show Manager reserves the right to reject, eject or prohibit any exhibit in whole or in part, or any exhibitor or his representatives, without giving cause. If cause is not given, liability shall not exceed the return to the exhibitor of the amount of rental unearned at the time of ejection. If an exhibit or exhibitor is ejected for violation of these rules or for any other stated reasons, no return shall be made.
11. Exhibitors are liable for any damage caused to building, floors, walls, columns, or to standard booth equipment, or to another exhibitor's property.
12. This contract must be accompanied with your payment. **NO boothes will be reserved without payment.**
13. CANCELLATION POLICY: Any exhibitor may cancel this agreement and withdraw from participation. Any cancellation after December 1, 2008 will not be permitted a refund, and will be considered a donation to the Kiwanis Club of Englewood-Cape Haze.
